



GDCTA Show Recognition Summary

GDCTA recognizes non-USEF(formerly AHSA/ USA Equestrian) /USDF/USEA (formerly USCTA)-sanctioned competitions in order for their results to apply toward GDCTA year-end awards.

Results from USEF, USDF and/or USEA sanctioned (recognized) horse trials, shows, etc. are accepted towards GDCTA year-end awards. There is no requirement for these competitions to request GDCTA-recognition (i.e. no application nor fee are required for results to count).

Non-sanctioned Combined Training horse trials, Dressage schooling shows, etc. may request GDCTA recognition prior to the competition. Events meeting the GDCTA standards and for which recognition fees have been paid are classed as GDCTA-Recognized.

For non-sanctioned competitions to be GDCTA-Recognized the following must be provided by the event manager/secretary to the GDCTA Show Recognition POC prior to the event:

1. Signed GDCTA Show Recognition Application
2. A check for \$30 per show (not per day) payable to GDCTA must accompany the application.
3. The name(s) of the GDCTA-recognized judge(s) scheduled for the event. The event must use GDCTA-recognized judges ("L" graduate or above; past or present judge; see list in USDF calendar of competitions for current judges)
4. Proof of Liability Insurance Coverage for the event (no specific limits).
5. The Event Prize list and/or Program with the GDCTA Membership Application included
6. The Event Entry form with the GDCTA Hold Harmless Clause included

Upon receipt of all or some of above items (minimum is an application and check), the GDCTA Show Recognition POC returns a GDCTA Show Recognition Checklist to the requestor certifying the event as **GDCTA-Recognized** (all items provided) or **GDCTA-Recognition Pending** (application and check have been received, but not all items provided). He/she also forwards the basic event information to the GDCTA Newsletter Editor and Web master for inclusion in our Calendar of Events.

GDCTA-Recognition Pending events are reclassified as GDCTA-Recognized immediately upon receipt by the GDCTA Show Recognition POC of all "missing" items, provided they are received prior to the event. GDCTA-Recognition Pending events that do not provide all of the "missing" items prior to the event are reclassified Non-recognized.

Events may advertise themselves as GDCTA-Recognized upon receipt of the signed GDCTA Show Recognition Checklist whether classed as GDCTA-Recognized or GDCTA-Recognition Pending. GDCTA understands that it is not always possible to complete all requirements prior to the application and strives to be accommodating and reasonable. Therefore, the Prize list, Entry form and/or Program may advertise the event as "GDCTA-Recognized" even though the event cannot meet all requirements until after one or more of those items are printed and received by the GDCTA Show Recognition POC.

During the show, the competition manager agrees to: (1) adhere to and enforce GDCTA policies and USEF rules (as reasonable in a schooling show environment); (2) maintain a copy of the GDCTA policies and USDF rules in the show office, and have available GDCTA Schooling Horseshow Evaluation forms for participants

The GDCTA Show Recognition POC does not "approve" show dates, nor ensure that shows on the same date are greater than some distance apart.

The person requesting recognition does need to be a GDCTA member beginning with the 2009 Show Season.

Officiating criteria: anyone who holds, or has held a USA Equestrian (USAE) (formerly American Horse Show Association (AHSA)) judge's license or anyone who has successfully completed the United States Dressage Federation (USDF) "L" Judges Education Program ("L" Graduates). "L" Graduates may officiate through Second Level. "r" Judges may officiate through Fourth Level. "R" Judges and above (including "S" and FEI "I" status) may officiate at all levels.

GDCTA Hold Harmless Clause

The undersigned competitor and all signors below hereby (1) agrees to release the management of this show, their officers, directors, employees, members, or agents, and the owners or managers of the grounds where this event is held, from any loss, damage, liability, or injury arising out of or resulting from this show or competitors participation therein; (2) agrees to indemnify, hold harmless and defend the Georgia Dressage and Combined Training Association, Inc., the organizer, facility owner, and the management of this show from and against any and all claims for loss, damage, liability, or injury, however caused, resulting directly or indirectly from competitors entry or participation in this show or from acts or omissions of competitor or competitor's agents; and (3) acknowledges that activities with and around horses and horse shows involve inherent risks that are understood by the persons signing and are expressly assumed. In the event of injury to competitor or to competitor's animals permission is hereby granted to management for emergency medical treatment.

Every entry at a Georgia Dressage and Combined Training Association, Inc. (GDCTA) recognized competition shall constitute an agreement and affirmation that all participants (which include, without limitation, the owner, lessee, trainer, manager, agent, coach, driver, handler, and the horse), for themselves, their principals, representatives, employees, and agents: (1) shall be subject to the constitution and rules of the GDCTA and the local rules of the competition; (2) represent that every horse, rider, driver, and handler is eligible as entered; (3) agree to be bound by the constitution and rules of the United States Equestrian Federation (USEF) and of the competition, and will accept as final the decision of the hearing committee on any question arising under said rules, and agree to hold the competition, the GDCTA, their officials, directors and employees harmless for any action taken; (4) agree that as a condition of and in consideration of acceptance of entry, they authorize the GDCTA and the competition management to market, transfer, assign, or otherwise make use of any photographs, likenesses, films, broadcasts, cablecasts, audiotapes, or videotapes taken of the horse(s) and participant(s) while on the grounds, incident to, or in transit between the stabling facility and the event site, in any way they see fit for the promotion, coverage, or benefit of the event, sport, or the GDCTA, without compensation to any of them, so long as the use neither jeopardizes amateur status nor endorses a specific product or service, and hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to invasion of privacy, right of publicity, or to misappropriation; and (5) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold harmless the GDCTA, the competition, and the officials, directors, employees, and agents from and against all claims including for any injury or loss suffered during or in connection with the competition, whether or not such claim, injury, or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees, or agents of the GDCTA or competition. The construction and application of USEF Rules are governed by laws of the State of New York, and any action instituted against USEF must be filed in New York State, see Article 1502.5.

Under Georgia law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Chapter 12 of Title 4 of the Official Code of Georgia Annotated.
