LEVELS:

Classes with more than 25 entries will be split into "A" and "B" sections.

ENTRIES:

Please fill out entry forms completely and correctly including signatures. If you have questions about completing the form or membership requirements, please contact the entry secretary prior to sending your entry. If entering both shows, please put ALL STALL info and payment on FIRST SHOW.

ENTRIES CAN BE COMPLETED ONLINE at **www.EqEntries.com** or by completing the entry forms included at the end of this prize list.

Management requests that all entries be created on EqEntries.com. If you do not already have a user account with EqEntries.com, please sign up. There is no charge to join EqEntries, create an entry or print an entry. So, if you choose to print your entry and mail it with a personal check, the service is free.

If you choose to enter the show via EqEntries there is a 5% fee to cover the transaction. We appreciate your using the preferred entry method. Online entries at www.EqEntries.com Questions regarding EqEntries, their services, or help can be obtained by emailing: Helpme@eqentries.com.

EXPRESS DELIVERY entries may be sent to the entry secretary at 6370 Spinnaker Lane, Alpharetta, GA 30005

Make checks payable to GDCTA and mail with entry form to Entry Secretary. Entries will not be accepted unless accompanied by full payment of all fees, copy of current legible Coggins (within 12 months), copies of all required USEF and USDF cards for rider, owner, trainer, coach, and horse with the entry form properly executed and signed. Entries will be accepted on a "First Come, First Served" basis. (USDF GR1509.2.a) We accept Visa, M/C, Discover and AMEX credit cards. Fee for paying directly to GDCTA by credit card is \$15.

All entries must be signed on all applicable lines. Competitors 18 and older must sign as trainer if they have no trainer who assumes responsibility for the horse at the show. Juniors MUST have their parent or guardian sign for them, as well as signing their own signature. Trainer signature must be an adult (over 18 years).

GR845 Equine Vaccination Rule 1. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables.

Management reserves the right to refuse any entry for any reason, and to combine, divide or cancel classes, substitute judges, or make any other changes as deemed appropriate at that time.

Entry must include full payment, all signatures, stabling information, copy of current Coggins, copies of appropriate membership cards, and horse registration cards or HID numbers. Horses with HID numbers only are not permitted to qualify.

Entries must be received in secretary's hand by closing date. Please sign the signature waiver on all entries delivered by ANY delivery service. Management is not responsible for late entries due to the signature waiver not being signed.

All Qualifying classes are combined with your division class. No separate ribbons or prizes will be awarded for Qualifying classes. Add a "Q" to the class number on your entry form to indicate Qualifying and add a USDF \$15 qualifying fee.

If entering Adult Amateur classes, USEF card must declare "Amateur". Specify test in Test of Choice classes.

No horse may compete in more than two consecutive levels at any one recognized show. Only one rider per horse in any one class. Lateness will result in elimination.

Entries may close early if time limits for judges are filled.

Stallions may be stabled adjacent to geldings. All efforts to isolate mares from stallions will be made, however, cannot be guaranteed.

Riders competing in more than 4 classes per day may experience short ride time intervals and must sign a time waiver or eliminate a class. All efforts to provide adequate intervals will be made.

All Horses must wear a bridle number when out of the stall.

Every class offered herein which is covered by the rules and specifications for the current USEF Federation Rule Book will be conducted and judged in accordance therewith.

USEF rules require that competitors must request permission of the show manager or show secretary prior to removing their horse from the show facility prior to the end of the show. (USEF GR805.01) Not scratching a class without notifying the show secretary prior to the class could result in elimination from all remaining classes in the show.

ENTRY ACKNOWLEDGEMENTS:

Entry acknowledgements will be emailed to the email address *legibly* provided on the entry form. If you do not receive confirmation within a reasonable time, contact the entry secretary. **Review the acknowledgement thoroughly for discrepancies**. All discrepancies must be resolved prior to closing date or entry may not be accepted.

ENTRY DOCUMENTATION REQUIREMENTS:

- Current USEF membership (or n/m fees) for Rider, Owner and Trainer,
 Coach
- Current USDF membership (or n/m fees, number) for Rider and Owner.
- Rider's USDF membership may be either Participating or Group, Owner's USDF membership may be Participating, Group or Business; if Rider/Owner's USDF # is a non-member ID #, the USDF non-member fee must be paid.
- USDF Horse ID.
- For Adult Amateur classes USEF membership card must declare Amateur.
- > Juniors and Young Riders must include birth date.
- Freestyle entries copy of a 63%+ (Training through Fourth) and 60%+ (FEI Levels) in the highest test of the declared freestyle level or any test of a higher level at a USEF/USDF licensed Dressage Competition.

FOR GAIG/USDF QUALIFYING CLASSES ALSO INCLUDE:

- Check "Qualifying" and add \$15 per Qualifying class.
- USEF and USDF Horse Registrations (not HID #s).
- ➤ Rider must have current Participating USDF and active USEF membership.
- Owner must have current Participating or Business USDF membership as well as current active USEF membership.
- Ownership must match between USEF/USDF. If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement it must be listed as an owner of the horse with both USEF and USDF.

ALL ENTRIES must have **THREE signatures - Rider, Owner and Trainer.** Legal Guardian must sign for riders under 18 yrs. Trainer blank must be signed by person over 18 who assumes responsibility for horse. (Parents who sign as trainer are exempt from membership requirements).

USDF Membership Requirements:

Either the HID# or a USDF Lifetime Horse Registration is required for all horses competing in the USEF/USDF recognized Dressage Competition or open class at a USEF/USDF recognized Regular or Local competition. *EXCEPTIONS:* Horses competing only in breed restricted dressage or DSHB classes at Regular competitions (i.e., all Arabian or all Morgan classes) or in USDF Introductory Level tests, Pas de Deux, Quadrille, and Opportunity classes are exempt from this requirement. Also exempt are riders in leadline, exhibitions, games and races, classes for 4-H members and walk-trot and academy classes. Any horse participating in a GAIG/USDF Regional Championship qualifying or championship class, or the USDF Horse of the Year award program must have a USDF Lifetime Horse Registration (LHR). All riders and owners must have USDF membership or Non-Member ID#. All horses must be USEF recorded, USDF Lifetime Registered or have Horse Identification numbers for both USEF and USDF (except IBC). Rider's

must be paid. If Owners' USDF# is a Non-Member ID# then the \$35 USDF non-member fee must be paid. If the Non-Member ID card is not available, then a \$5 affidavit fee must be paid. Rider must pay a non-member fee if they are not current USDF Participating or Group Member. Owner must pay a non-member fee if they are not current USDF Participating, Business, or Group Member.

USEF Membership Requirements:

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) lead line; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR218) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF Introductory level tests, Pas de Deux and Quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

http://www.eqverification.org/ is an excellent site to research and print all your entry USEF/USDF memberships and registrations. You can print all your cards in one place and send the complete document with your entry

GUEST HORSES:

Guest (non-competing) horses are welcome, as entries permit. Submit a complete entry form (including signatures), copy of current Coggins, guest horse fee, office fee, and stabling fees. Guest horses are restricted from using warm-up arenas while classes are conducted.

LATE ENTRIES:

Entries not in the secretary's hand on closing date (postmarks are not relevant) are considered post-entries and will be accepted at the discretion of show management. If accepted, they will be assessed a \$35 late entry fee. If show has filled prior to closing date or by closing date, late entries will be put on a wait list.

ENTRY CHANGES:

Changes to the class schedule may be accepted at the show secretary's discretion. Changes requested and granted by the show secretary will incur a \$20 change fee. There will be no charge for changes prior to the schedule being set. Substitution of riders after closing date is not permitted. If a rider change is needed, a separate entry must be submitted and is subject to all policies and rules regarding entries.

REFUNDS:

Before closing date, fees will be refunded less the office fee. After closing date, a credit slip will be issued for either the Labor Day Classic I or II. Credit must be used in 2021 or else the funds are forfeited. Credit slips are only issued with a signed vet or doctor report submitted to the secretary within one week of the show date. Unconditionally, no refunds after closing date or for "acts of god" which require management to cancel classes or day(s) of competition. Any unused USEF or USDF fees will be refunded after any indebtedness is settled.

Returned check & refused Credit Card policy: Void entry and incur a \$35 charge. Entry will be wait listed until credit card clears or cash is received. Do not mail cash.

STABLING:

Stabling is mandatory. There are 268 (11x12) permanent stalls with sliding doors. Initial bedding (as described in Fees) is provided by management. You may order additional bedding with your entry form. It will be in your stall when you arrive. Missing bedding is not the responsibility of the facility, the show, or show management. Exhibitors are NOT PERMITTED to use nails or screws for attaching decorations, or hanging tack, supplies, buckets, etc. Stabling is Mandatory.

May arrive on Friday after 12:00PM, must vacate by 7:00PM Sunday. Earlier arrivals and later departures must get permission from management and pay \$40/night fee. NO paddocks are available.

STABLING GROUPS:

Please use **ONE Consistent GROUP NAME** for everyone who wants stabling together in a single GROUP. Please be consistent! Show management is not necessarily familiar with farm names and is not responsible if you are with the wrong group. A group map is a great help if you have specific needs. If entering both shows, please put ALL Stall information on the FIRST SHOW forms.

NIGHTWATCH:

Sweet Dreams Night Watch will be on duty with continuous rounds all night. Please make sure you have contact information posted on your stall (hotel, cell number, etc.). See page 2 for advance contact information if you want enhanced services.

ADDITIONAL BEDDING:

Additional bedding is available on the grounds through the show office or \$9/bag for pre-show orders. Pre-ordered bedding will be in your stall on arrival.

RV's & TENTS:

Hookups are available for \$40/night. Tent (rough) camping \$20/night. Please include on your entry form. Receive an identification placard to place in your vehicle/tent when you pick up numbers.

ARENAS:

All classes will be ridden in a standard arena (20x60 meters). One covered arena and two or three outdoor arenas with sand footing. Two large warm-ups with footing identical to competition arenas. Lunging is permitted in designated areas and will not be permitted in the arenas, warm-up, or grass. No one is permitted in the warm-up arenas on foot or permitted to sit on the fencing.

TIMES:

Un-official times will be posted on the GDCTA website (www.gdcta.org) no later than Tuesday before the show. Official times will be available at the show office on Friday at noon. Tentative start time: Saturday at 8:00 AM

PONY MEASUREMENT:

If your pony requires measuring, please contact the show secretary at least one week before the show. Measurement of ponies will be conducted Saturday. All expenses related to the measurement will be the responsibility of the owner of the pony or ponies. This will be the only time for pony measurement. Expenses may include vet travel time and trip fees, and any other expenses not normally encountered at a recognized horse show. Ponies must be measured before competing in "pony only" classes.

FREESTYLES:

Effective December 1, 2019, the Freestyle prerequisites listed in USEF Rule DR129.9 are changing as follows: DR 129.9: "Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior, FEI Young Rider and FEI Para-Equestrian Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth Levels and 60% for FEI levels in the highest test of the declared freestyle

level or any test of a higher level at a USEF/USDF licensed Dressage Competition, Federation Licensed or FEI recognized Dressage Competition, or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. USEF DR128.9. (Training Level Freestyle is NOT a qualifier for the Great American Insurance Group/USDF Regional Championships.)

If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Any vehicles parked in the fire lane or barn area for more than 15 minutes for loading and unloading may be ticketed and/or towed at the owner's expense.





USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

 Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDFrecognized Dressage competition within the qualifying period of the applicable regional championship.


b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

2021 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2021 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Junior Active, Senior Active, or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.
- * PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

- ** Horse must have a USDF Horse Identification Number or LHR
- ** Owner must have a USDF PM, BM or non-member number

- **Competition year starts January 1 and ends December 30

<u>USDF Membership Benefits:</u> USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at www.usdf.org.

Membership Requirements for USEF-licensed/USDF-recognized Competitions:

Owners and riders, including foreign riders

and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
 sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
 Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
 exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
 academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. **Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan VISDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.


